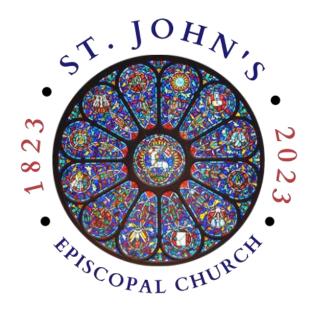

Celebrating Successes & Saying Farewell



Dear Friends in Christ,

In a few short weeks I will be leaving you as your rector. As I reflect on our time together, I think about the spiritual growth that has taken place, as well as all we have accomplished together. I find my heart very full and grateful for the time spent with you. We have faced challenges and survived (and even thrived) during a pandemic! In this post-pandemic time, we have begun to regain our footing and rebuild vital ministries that have helped define St. John's over the years.

This past year we said goodbye to some important team members: including the Rev. Dr. Katrina Grusell, Associate for Pastoral Care; and Jason Largent, Minister of Music; and this coming week, Russ Warner, our Facilities Director. We have also

welcomed Justin Pechulis, our new Music Minister; and Brad Jones, our new Facilities Director. We kicked off our Bicentennial Celebration Year with tours of our Historic Church and special worship offerings. We have entered a relationship with Peabody Conservatory to offer music lessons here at St. John's. Additionally, a team of dedicated parishioners worked diligently to update the parish by-laws and those will be brought before you for discussion and approval in a special parish meeting later this year. This past September we "tried on" a child-focused 9:00 a.m. Sunday worship service under the direction of Chaplain Kiona Lookingbill. Moving forward, we will be working with Virginia Seminary to enhance our Family Ministry. Our Small Group and Bible Study Ministries continues to grow and thrive under the direction of the Rev. Stephen Hagerty, Senior Associate Rector, and our Youth Ministry is rebuilding post-Covid with a group of dedicated leaders committed to our young people. The Adult Formation Commission has been meeting to discern next steps for 2023-24 and the Center for Spiritual & Mental Wellbeing has some new offerings for the Fall that will continue to help us grow in new ways.

Our Labyrinth Ministry, under the direction of Teri Salmons, is now recognized nationally; another exciting new ministry that took root this past year is our Garden Ministry. The Garden Ministry will coordinate with the Buildings & Grounds Commission on the work necessary to care for the beautiful campus that God has gifted us in ways that are sustainable and honor God's creation. (Did you know that our rain gardens save the parish \$6K in county fees each year!?) All our commissions including Outreach, Social Justice, Youth, Children's Faith Formation, and Pastoral Care have been discerning next best steps for their areas of practice and I am excited to see what the future will bring in the hands of so many dedicated followers of



Jesus. We have accomplished much and grown even deeper in our relationship to God and one another over these last six years; you have demonstrated that St. John's is a resilient and vibrant community of faith!

We have not been without our challenges this past year. Our buildings are aging and the Buildings & Grounds Commission and Facilities Maintenance Team, under the dedicated leadership of Mike Salmons, Junior Warden, are working hard to stay on top of maintenance needs and those areas that have been deferred for some time.

The cost of running a campus our size — a campus that is a true gift to the community — can outpace our stewardship and we ran into that this year when faced with replacing the air conditioning in the Shiflet Center for Ministry and Education. Through the diocese, we were able to obtain a Diocesan Middendorf Loan to be paid back over the next ten years at an extremely low interest rate. The Parish Day School will

help in repayment of the loan as part of their Memorandum of Understanding (MOU), which is currently under review. We have also applied for some relief from our Diocesan Assessment, which we did last year as well. During the pandemic, we did not have to request relief. We finished 2022 with a modest deficit of approximately \$7,650. Over the years, St. John's has relied on our diocese for financial support and it is my hope as you move into the future stewardship will grow to support the needs of the community. This is an area that will require intentional work and commitment from everyone in the parish. In one of the wealthiest counties in the nation, the giving at St. John's is well below the national church average. If everyone in the parish made a commitment to sacrificial giving, to give a minimum of 3% of their net income (7% below the biblical tithe of 10%), St. John's would not be struggling financially. If you are to grow and thrive in the next 200 years, a focus on sacrificial giving and a capital campaign to retire parish debt will help get you there. Please know how grateful I am for the generosity of so many of you and especially the work of the Stewardship Commission. This year we had 30 new pledges! Please consider being part of the Stewardship Commission. Every commission has a vested interest in the finances of the parish and representation on the Stewardship Commission will ensure those interests are addressed.

This Spring the Vestry began work with the Rev. Dr. Kristofer Lindh-Payne using the College of Congregational Development model *Gather, Transform, Send,* to identify and implement some goals for the coming year. Rev. Kristofer will continue working with the parish. I encourage you to reach out to a Vestry member and ask how you can be a part of this important work.

An area that will also require some work will involve increasing volunteer numbers in all our worship ministries. The pandemic really took its toll and if we are to continue to offer beautiful and welcoming worship, additional ushers, readers, Eucharistic Ministers, vergers, Eucharistic Visitors, altar guild members, acolytes, and AV tech volunteers, as well as leadership are needed to support many of these ministries. Our current leaders have worked incredibly hard during the pandemic, and I am grateful for their dedication and servant hearts. I invite all of you to renew the commitment you made at Baptism and I hope and pray the opening words of the acclamation for the service of Baptism: "There is one Body and one Spirit; There is one hope in God's call to us; One Lord, one faith,



one Baptism; One God and Father of All" ring true for you as much as they do for me. I am grateful for all our lay ministers that continue to answer God's call.

Though this last year was challenging, because of the leadership of the following, it was also fruitful: Scot Millen, Senior Warden; Mike Salmons, Junior Warden; Ann Corbett, Treasurer; and Beth Mackey, Registrar. These four gifted and dedicated individuals not only worked extremely hard on your behalf but also provided me with a depth of wisdom and support that was unsurpassed. They are one of the finest leadership teams I have worked with throughout my career as a rector and your Vestry was equally committed, collegial, and hardworking as well. This past year an update of the by-laws was completed as well and will be brought to a special meeting for parish approval.

The staff of St. John's has worked diligently to support the mission of St. John's often going above and beyond to ensure all our commissions had what they needed to be successful. Their support of worship ensured that parishioner and newcomer alike had everything they needed to worship fully. It is easy to take for granted what happens behind the scenes to keep St. John's running smoothly day in and day out; I want to take this opportunity to thank the staff for all you do that most of the parish does not see. The staff at St. John's are compassionate and grace-filled professionals and I will deeply miss working with such a fine team. I am also grateful for our amazing team of office volunteers who faithfully



answer our phones and support the office staff and all of you. If you are interested in serving in this capacity and have time each week, please contact Kathy Young in the office.

These past years would not have been the same if I did not have the privilege of serving alongside the Rev. Stephen Hagerty, Senior Associate. His leadership, depth of theological knowledge, spiritual grounding, and preaching skills not only contributed to the growth of our Small Group and Bible Study ministries but to the growth of the parish on many levels. He has truly been a partner in ministry here at St. John's, and he is one of the finest and most faithful priests I have had the privilege to work with in my ministry. He not only provided pastoral support to the wider parish but also supported the work of our Youth Ministers, Women's Bible Study, and the Adult Faith Commission. Rev. Stephen is a valued colleague and friend, and I am grateful for his support and his love and care for the St. John's community.

This past year we also said goodbye to the Rev. Dr. Katrina Grusell and I am grateful for the work she did to prepare our Pastoral Care Commission and leaders to continue their work in caring for our community. I especially want to thank Karen Ferguson, Carol Diggs, Tina Millard, Judy Anderson, and Sue Carlson for their dedication and leadership. Pastoral care under their leadership continues to grow and flourish. The Center for Spiritual & Mental Wellbeing is now operational and has begun work developing programming that will serve the community well into the future. I want to thank Karen Ferguson, Tarpley Long, and members of the Advisory Board that continue to bring a long-held dream to fruition.

While the pandemic certainly affected how we have worshipped at St. John's, it has not stifled our growth. We continue to add new folks each week and we are seeing growth at all our services. In the last year, our Saturday evening service has doubled in size as has our 9:00 a.m. service in All Saints Hall. For the first time in three years, we had standing room only on Easter Sunday morning at our 10:30 a.m. service. We also began offering a monthly Youth Service ("Faith First @ Five") that has been well attended by our youth and their families. Our Newcomers Ministry



has new energy and Brian Stone and Clare Brooks, along with our newcomer advisory group and vestry, are working to ensure this important ministry has all the resources it needs to invite, welcome, and connect newcomers to St. John's as part of our growth strategy.

The Parish Day School (SJPDS) continues to flourish under the direction of Ms. Lori Dembo and I am grateful for her leadership and for the faculty, staff, and the SJPDS Board of Trustees. This year the school was re-accredited through The Association of Maryland Schools (AIMS), and for a second year in a row registration for next year is almost at capacity (before the end of the school year!) and school finances remain strong. The parish and school are fine-tuning our previous MOU to include the Mittendorf Loan for the AC system. As I said last year, the MOU, like our budget, is a living document that is reviewed and adapted each year to ensure the stability of the Parish Day School and St. John's Parish.

Friends in Christ, I want to thank you for the many mays you have enriched my life and made God's presence known while I have been with you these last years! Because of you I am a better priest and and am prepared to take on new responsibilities as a Suffragan Bishop of the Church. I hope you will join me on Sunday, May 21st as we say our goodbyes. Know I will be holding you all in my prayers as we continue to serve Christ in and through the Church.

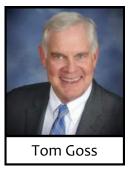

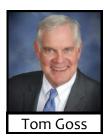

VESTRY MEMBERS offer their leadership to serve the mission of the congregation — "to strive to bring all into a closer relationship with God and one another through Jesus Christ." Vestry members serve the entire congregation rather than represent one specific ministry. They also continue to serve in the ministries of the parish, practice sound stewardship, and support our bishop and diocesan ministries.

The Vestry includes the Rector, who serves as the presiding officer, and an elected group of parish members. Together, this group is the legal governing and decision making body of a parish with regard to all matters pertaining to the church and its operations. As the presiding officer, the Rector only votes on matters when there is a tie among the other Vestry members.

Vestry duties include creating, approving, and implementing the budget, developing policies, and supporting the mission of the congregation through spiritual leadership. At large churches, such as St. John's, this includes planning and oversight. Operational, spiritual, and liturgical decisions are left to the Rector, staff, and commissions. The work of the Vestry, in collaboration with the Rector, includes identifying goals, opportunities, and challenges; creating a vision that aligns with our mission; monitoring steps toward implementing the vision; overseeing financial health and progress; developing leadership in commissions and committees; communicating with the parish; and ensuring the financial stability of the parish.

Buildings & Grounds



Junior Warden's 2023 Buildings & Grounds Report Submitted by Mike Salmons

Though there are certainly many success stories to celebrate this past year when recounting all things maintenance, repair, and better business practices, it has, however, been an extraordinarily challenging year dealing with equipment and infrastructure failures at an unprecedented rate and scope. I would honestly say

that many of us earned our triage badges these past 12 months while learning to juggle the myriad of repairs. Of most notable significance was the need to replace the air conditioning chiller unit and ancillary systems in the Shiflet Center for Ministry & Education (CME) at a cost of over \$350,000.

Through all of this, however, the Junior Warden, Director of Facilities Operations, and Buildings & Grounds Committee never lost hope, or its focus on finding good solutions, the right contractor, or the needed funding for the tasks at hand. We have certainly been blessed this year to have found a team of contractors and service companies that often went above the call of duty to respond to emergencies and offer discounts recognizing our financial constraints. Not often seen in this day and age, we have established some exceptional relationships with those who keep us operational and safe. Looking back over the past couple of years, it has never been more clear to us who work so tirelessly to help maintain and safeguard campus structures, grounds, and infrastructure that the current level of funding and maintenance staffing is not sufficient enough to stay ahead of the issues we've experienced. In the months ahead, renewed emphasis on conducting a reserve study along with maintenance assessments will need to be considered.

On a positive note, improved protocols and policies in such areas as outside space rental agreements, memorial gift giving, campus signage, and vetting contractors and vendors have helped to streamline day-to-day operations for office staff and facilities operations. In concert with the Head of the Parish Day School, Lori Dembo, the committee continues to identify both challenging and earth-friendly projects for local Eagle Scout candidates to undertake across the campus. And as we continue to slowly reemerge from COVID isolation, the volunteer pool to help with projects and tasks around campus is certainly growing in size.

Overall, our buildings and grounds continue to support our ministries, missions, and parish community in wonderful fashion.

Some highlights from the past year are shared below:

Buildings:

Rose Hill received a major facelift across the entire ground floor with the addition of new vinyl flooring, new hallway carpeting, new paint, new window treatments, and new furnishings in support of the Center for Spiritual & Mental Wellbeing.

Funding was secured through a loan from the Diocese of Maryland to support the procurement and installation of a new rooftop A/C chiller unit along with supporting equipment for the CME. The new equipment is scheduled for installation in June 2023.

The organ in the Historic Church underwent a major transformation earlier this year taking it from an instrument that pushes air through pipes to an instrument of digitally-induced sound. The cost savings was significant by choosing this method of repair and the sound is remarkably similar to the original format.

Building and Grounds

The Johns Hopkins Peabody Institute continued its rental agreement for the use of the Clark House for its voice and musical instrument instruction. The building is being well cared for by our renters and the program has been a great source of income for the church.

Funds were raised for a major rebuild of the historic Crèche that adorns the church lawn during the Christmas season. New roofing, siding, and improved electrical circuitry is planned. Volunteers, many who have special connections to its rich history and original build, worked in April to assist with the repairs.

A vast number of smaller maintenance and repair events occurred across all buildings this past year that included two new hot water heaters, the cleaning of



the All Saints Hall (ASH) ceiling and air ducts, repairs to the maintenance shed roof to address leaks, and fine tuning of the A/V console in the Historic Church to improve livestreaming feeds for Sunday services.

Grounds:

Two comprehensive site assessments were conducted by local ecology and landscaping experts producing reports on how well the church was fulfilling its pledge to minimize and mitigate storm water

run-off into the Chesapeake Bay. St. John's is currently fulfilling its responsibilities well.

The Vestry approved a landscaping proposal submitted by the Garden Ministry to accept 19 free trees and 3 new gardens, all from species native to Maryland and all inviting to pollinators. The project is possible from grants secured by Howard County EcoWorks. The new vegetation, planted and secured by EcoWorks teams, was added mid-April 2023.



The Outdoor Classroom, located behind the Historic Church, and established and maintained by the Parish Day School, received a comprehensive refresh last fall thanks to contributions made by school supporters and a local landscaper.

Fall and Spring Campus Clean-Ups continued to bring together volunteers for the beautification of the campus. Special recognition is in order for the many Parish Day School staff, parents, and students who always support this effort.



Building and Grounds

The Year Ahead:

In plotting a course over the next 12 months, that plan will take shape as the new Junior Warden gets established and gets briefed by Facilities Operations during May. A few special focus areas are outlined below:

Water continues to seep through PVC conduits housing electrical wiring ending in the Boiler Room and IT Computer Rack Room in the CME. The leak origins are somewhere underground near the south and west lawns of the building, respectively.

Concrete repairs are needed for the sidewalk and ramp leading from the Lower Commons entrance to the CME behind the Clark House. Being a trip hazard, it will remain a priority.

Despite an increase in numbers of parishioners volunteering to help with projects around the campus, the need for more help cannot be emphasized enough. Our campus and facilities are vast, and the many moving parts can easily overwhelm our maintenance staff. It is the intention of the Buildings & Grounds Committee to design small projects, like pruning/ weeding/mulching, landscaping, planting, painting, etc., and set up small teams to tackle them; more to come on this endeavor.

Heartfelt thanks to the members of the Buildings & Grounds Committee, Steve Davey, Geoff Walker, Denny Donovan, Brad Lieberman, Dave Maas, Lori Dembo, our Director of Facilities Operations, Russ Warner, and our well-seasoned facilities maintenance technician, Warren Harris, who all endured a constant whirlwind of maintenance challenges and demands this past year. Unbelievable teamwork and perseverance by all.

As I step down from serving as your Junior Warden these past two years, I am forever grateful for not only the wealth of knowledge imparted to me by our Facilities Director, Russ Warner, on all things hvac, electrical, plumbing and mechanical, but for the incredible support he provided to both the Buildings & Grounds Committee, and to me, personally. Enduring many, many late nights and early mornings, large rental events, numerous health and safety inspections, late arriving contractors, lost parts in the mail, unexpected ice storms, leaking ceiling pipes, misbehaving thermostats, and especially creative financing for projects and maintenance....Russ has been a warrior. It has been an honor working along side of him.

St. John's Parish Day School (SJPDS) Head of School Report Submitted by: Lori Dembo, Head of School

We welcomed the 2022/2023 school year with MOST open arms as we were welcoming back students, staff and families to a happy and healthy campus for all intents and purposes free of the once necessary trappings of the pandemic!

It has been a year of many important accomplishments, but the one I'd like to particularly highlight is our having passed with flying colors the AIMS (Association of

Maryland & DC Schools) decennial accreditation for our school! For four days last fall we hosted the accreditation committee as they evaluated every aspect of our school from meetings with Trustees, PA Board members, and staff to in-depth exploration of all facets of SJPDS and our extensive programs. This elaborate process fully accredits us at the highest level of certification for independent schools. We will give weighty consideration to the findings included in the feedback report as we craft our Action Plan and begin working on our Strategic Plan for the next five years as our guiding goals.

A brief chronological accounting of the year and additional successes:

Summer found us in all the usual busy preparations for the year to come, including onboarding wonderful new hires and hosting the ever-popular End of Summer Social. September 6th we opened our doors to 173 Early Childhood (EC) and 145 Lower School (LS) students. It was one of our best homecomings ever given we were not only happily reunited, but for the most part, seeing each other's smiles once more with our optional masking policy. A long-overdue "normalcy" prevailed and we couldn't have been more appreciative! The School redid our fantastic Outdoor Classroom and we continue to make ongoing upgrades with the help of our very dedicated Eagle Scouts. Visit Days, First Day of School, and Back to School Night were all very well-attended! October brought us Episcopal Schools Celebration Week, Blessing of the Animals, Conferences, Open Houses, Fall Family Fun Day, an Hispanic Celebration Concert, and Halloween! November saw Student Council elections, Road to Kindergarten, Donuts with Grown-Ups,

Veterans Day Celebrations, yet another well-attended Open House, Grandparents Day, and Thanksgiving! December was of course all about Christmas! 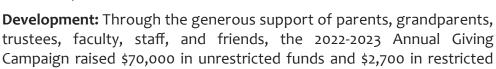
Our Board of Trustees (BoT) has worked tirelessly to increase the salaries and benefits for our dedicated faculty and staff. This year we enjoyed a 98% retention rate for our faculty and we are on track to stay the same for next year. We know how valuable our faculty is and work hard to reward them accordingly. For next year, we will enjoy 5% raises across all areas, an increase in our United Health Plan contributions, and discounts for a faculty member's child(ren). Additionally, the BoT has worked to intentionally honor our AIMS' required standard for our Reserve and Endowments Funds to ensure a fiscally-sound future for our wonderful school!

St. John's Parish Day School

Admissions: Our halls for the 2022-2023 school year have been filled with the joy of 318 students. Our admissions department hosted four in-person Open Houses and one virtual Open House totaling well over 110 guests. In addition to these Open Houses, we also welcomed over 30 families through private tours and have many more scheduled. These visits have assisted in fulfilling our enrollment numbers for next year to 300 students and counting. Our "Road to Kindergarten" program held virtually for both current Early Childhood and new families was a huge success allowing us to have our Kindergarten waitlisted. For our current Fifth Grade class we hosted an evening Road to Middle School program to help navigate the Middle School enrollment process as well as provide insights to the students from our alumni. We are ecstatic to report 100% acceptance to every Middle School applied to for all of our Fifth Graders! We are so very proud of them and all their hard work! Go Bears!!!



We welcomed our new families for next year with a fun New Families Celebratory Drive-By! As families drove up to the building they were given "swag" bags of fun St. John's items by our staff members and our mascot, Spirit Bear! We are planning an additional event for our new families in May. We have limited openings in both our EC and LS classes for the 2023-2024 school year and many programs are currently waitlisted. We are thrilled with the response and are extremely proud of our community!





funds as of March 2023! This dollar amount reflects monetary annual gifts, exclusive of numerous in-kind contributions and capital donations. Our success is measured in more than dollars, however full participation is an important goal of our campaign, as well. Once again, the Board of Trustees and faculty/staff demonstrated their continuing commitment to our school and student excellence by reaching 100% participation! Also, our amazing community has fully participated in our annual lead donor event, Grandparent's Day and our Valentine's Day 'We Love SJPDS' spirit wear sale. We are looking forward to our Creative Spark Student Art Show fundraising event happening on May 5, 2023 and increasing local business support through our new Biz Partnership program in the upcoming school year and beyond.

Marketing and Communications: This year our focus has been on brand recognition and creating new handheld marketing materials. Our previous flyers, brochures, and informational packets are being redone to more accurately reflect the wonderful current community at SJPDS. Another primary focus has been the SJPDS website. There have been multiple updates made to the current website to reflect ne professional photos, as well as removing unnecessary pages and links. While this has helped, it has been decided that SJPDS will begin researching a new website hosting platform to accommodate our large website and help with future needs.

St. John's Parish Day School

Social media marketing and Search Engine Optimization (SEO) are items that continue to be a daily focus to help broaden our reach outside of our current SJPDS community. Utilizing Facebook and Instagram as marketing tools has helped to highlight happenings within our school and gain a larger following, including those not currently in our school community. This has led to increased interest in our programs, a larger reach within our area, and broader brand recognition throughout Maryland. Additionally, we are very proud to note that SJPDS has received an A+ rating from NICHE 2023 Best Schools (the top rated search engine for parents) for the third year in a row as well as being the top ranked PreK – Grade 5 School in Maryland! GO BEARS!!

Auxiliary Programs: We have seen tremendous growth in every respect during this school year. Before and Aftercare saw an increase in regular and drop-in attendance resulting in increased gross revenue by 41.85% as of March 2023. To accommodate this growth, specifically in After School Care (3:00 – 6:00 p.m.), we expanded our program to include seven classrooms for over 100 students using the program daily. This year, hundreds of students have participated in over twenty afterschool Enrichment Programs offered during the fall, winter, and spring sessions. We have added three Lower School summer camps specializing in different areas of interest: movement, natural sciences, and reading enrichment to complement our Early Childhood Camp which will run for ten weeks between June 12 - August 18. We are projecting to exceed our revenue numbers from last summer.

Though SJPDS is very grateful for all our blessings this fantastic school year and all it has brought and meant, we still look forward to the coming 2023/2024 school year with its future achievements, gifts, and of course, challenges. Onward and upward, SJPDS Bears!

Korean Ministry Report Submitted by: The Rev. Barnabas Lee Associate Rector & Diocesan Asian Minister

In 2022, the community was depressed due to the pandemic. Elderly people left for other states and families with teenagers left for other churches for their children. We held joint worship services and made efforts for recovery.

Nevertheless, about 10 folks attended worship on Sundays.

Because of this, we are continuously preaching through the internet, and people have participated through You Tube, and our church website.

Interestingly, the Book Club that gathers every Saturday morning is growing.

We meet to read a book and discuss various readings. There are more than 15 members. I think of it as an activity for the restoration of faith and recovery in the Korean community.

In addition, I was invited to an assisted living home, known as "Morning Glory" to regularly visit and pray for 20 patients and staff, help in taking care of elderly, give them counseling, and pray with them. I also visited a Korean senior center as well, and involved Korean community organizations in this area too.

Since 2023, the Korean community and Korean immigrant groups have been more active. Therefore, more contacts will be made through active meetings and participation. In particular, we will do more activities for social participation and religious guidance for Koreans. And we will carry out activities for evangelism to make ourselves known. We will continue our efforts to let people know who we are so that they can participate in our worship service. They may also be interested in participating in the American community.

Korean immigrants still face insecure lives and various difficult problems. Hate crimes, various discrimination, and uncertainty threaten Asians. They also have experiences and cultures that are difficult to accept and may be unwelcome in mainstream society. We will actively participate in guiding them to actively participate in American society and help the Korean community to do what they can do together. It is because there is a voice demanding work in our church.

I hope to spread the Gospel of the Lord among all the people.

Music Ministry Submitted by Justin Pechulis, Director of Music Ministries & Organist

"Be joyful in the Lord, all you lands; serve the Lord with gladness and come before his presence with a song." – Psalm 100:1

In the few short months since my arrival at St. John's, the music ministry has continued to be very active in our weekly worship and at additional special events that have been held on our campus. The music program consists of many dedicated members who make up the St. John's Choir, the St. John's Ringers, the Instrumental Ensemble, and the All Saints Hall "ASH" Band. All of these groups provide music in worship regularly, and give a wide variety of musical offerings for parishioners in both the All Saints Hall 9:00 a.m. service and Historic Church 10:30am service to enjoy.

The big development of this past year has been the conversion and installation of the digital organ. Once it became apparent that the work needed to repair the pipe organ was beyond the capabilities of the parish budget, the organ committee contracted with Walker Technical Company, of Allentown, Pennsylvania, to develop and install a new digital instrument. The technicians arrived in February to dismantle the old system, and install the speakers, an electronic relay system, and update the organ console (where the organist sits) to match the settings of the new digital



sounds. At the end of the month, Dan Angerstein, of his own company in North Carolina, arrived to provide tonal finishing work, essentially "breaking in" the organ to adjust to the space of the nave. After the organ was completed, it was kept silent through Lent, and the big reveal was held on Easter Sunday. This new instrument, given proper maintenance, will last the church several decades.

The music ministry had the special opportunity to be involved in the Diocesan Convention held at the parish on March 25, which elected our Bishop Coadjutor. The St. John's Choir combined forces with choirs from St. Andrew's in Glenwood and St. Mark's in Highland to present their musical gifts for that morning's Eucharist service. The music directors from all three churches hope to have further collaboration down the road from time to time.

St. John's also continues its partnership with the Howard County Concert Odyssey, which makes use of the Historic Church to bring the performing arts to the church and the greater Ellicott City community. The Odyssey board is partially made up of several St. John's parishioners, including its President, Nancy Mason. As we move toward the next program year, it is my hope that the church can host its own in-house concert

series, consisting of performances which would include members of our parish music program. In that light, we are beginning to put together a concert program which will celebrate the church's 200th Anniversary, and dedicate our new digital organ. Stay tuned for more information in the coming months.

Music Ministry (continued)

I would like to extend my own thanks to the many dedicated individuals who have given countless hours of their time to ensure the parish's music ministry operates smoothly, and assisted me as I assumed my responsibilities at St. John's, especially Scott Geist, for his leadership with the All Saints Hall Band; Nancy Miller and Donna Hesson, who continue to assist with organizing the choir robes and library; Susan McKenzie, for her assistance with the bell choir, especially when that group collaborates with the St. John's Choir,: and Susan Fedors and Drew Carlson, who organize members and music for the Instrumental Ensemble. Finally, I would like to acknowledge Jason Largent for all of his work leading the music program through the past three years of "pandemic-tide"; it is a healthy and vibrant ministry due to his dedicated leadership.





As part of Ellicott City's 250th Anniversary Celebration — and to kickoff St. John's Bicentennial Celebration in 2023— St. John's hosted a tour of our campus, educating visitors on the historic aspects of our campus including the Historic Church and its stained glass windows, Alda's Chapel, the Labyrinth, and Brittany's Garden.

Karen and Katie have been involved with the Survivor Program for our 4th and 5th-Graders. They have served for the past 3-4 years; this will be their last year serving on the Commission. New members of the CFF Commission are: Lauren Comber, Danielle Gottwig, and Beth Jenior. We are thankful for everyone's time, gifts, and dedication. Over the summer, we had Explorers' Weekend with the theme: "Jesus is My Super Hero". Children had a wonderful time learning about Jesus' super powers, making super hero crafts, doing a Scavenger Hunt, and presenting at the Talent Show.

During Advent, we had a Christmas Social for families with children where we made Christmas ornaments, lit the Christmas tree, sang carols, and socialized over treats.

On Christmas Eve, 2022, we held the Crèche service with the children's bell choir and piano accompaniment by Chaplain Kiona for praise & worship in ASH. We brought back the Christmas Pageant also, which traditionally was done by Youth. The children did a fantastic job reading and illustrating the Christmas story through silent acting.

Youth Faith Formation Report

Youth Formation is an ever changing ministry: not only are young people in the time in their lives when they are going through rapid transitions, but each generation and sub generation brings new trends, advances, and understandings of the world. That's a lot to work with! As we are three years out from the start of the COVID pandemic in Maryland, it is nice to look back and see how strong our program remained despite incredible challenges placed on top of ever-changing ministry. Though we took a dip in

our registration, we are slowly growing as we see new families beginning to attend and families return. The relationships that have developed only get stronger with each passing month and the dedication of our leaders is inspiring. We have youth who serve as acolytes, Eucharistic Ministers, lay readers, PowerPoint operators, ushers, and representatives on the Outreach Commission and the Garden Ministry Team.

Here is a look at some of the highlights of the 2022-2023 program year:

J2A leaders, Rev Stephen, and I interviewed seventeen 9th and 10th graders to discover if they were ready to be confirmed. Fifteen of those youth were confirmed on May 21st!

We recognized our nine wonderful seniors and blessed them as they prepared for their next chapter.

J2A had a lot of preparation to get the youth and leaders mentally and physically ready for their time in Maine. For seven days, 12 youth and seven adults became part of the community of Ocean Park, Maine. Not only did they walk 8.4 miles, canoe through wetlands, climb along the rocky shore, and sing songs around a campfire, but they also led morning and evening prayer, learned about monastic life, lived without technology, and experienced Eucharist on the beach at sunset. After coming back, several youth shared that their pilgrimage brought them closer to God and acted as a catalyst for deepening their faith and



connection to St. John's. Months later, youth shared their experiences with a group of family and church friends who supported their pilgrimage through Shares of Love.

Our 2022-23 program year started off very successfully in September. We averaged six in Rite-13, 15 in J2A, ten in YAC, and three in SWAAG. These numbers stayed steady throughout the program year. Traditionally, after J2A, the group begins to thin. We are really proud to have a consistent group of YAC that is still engaging with each other and the Parish.

In order to take some weight off the shoulders of our youth leaders, we changed our language and created "mentors" and "organizers" in each of our four groups to help lead. The mentors are responsible for leading the lessons and being in the classroom with the youth. The organizers help send communications, set up sign ups, order pizza, gather supplies, etc. They are also filling in as second adults on Sundays as needed. Our mentors, many of whom are returning from the previous year, are pleased with the extra support and feel more able to focus on teaching their lessons. This has worked the best in J2A and we hope to further it for the 2023-24 program year.

Youth Ministry (continued)

We began using an updated version of the Journey to Adulthood curriculum -(updated July 2021). The material contains updated language, technological additions, ZOOM adaptations, and deeper scriptural teachings. We have had good feedback on the lessons.

At One Worship, we welcomed the rising 6th graders into our fold and celebrated their milestone.

We were happy to welcome Grassroots back in the fall to offer QPR suicide training for our youth. This training aimed to empower our youth to speak up and help others if they see a need. It is also a good way to help those who may suffer from suicidal thoughts without directing it towards them.

Rite-13 hosted the Blessing of the Animals in October. We had 25 animals with their families who were blessed, given a certificate, photographed, and petted to glee! Donations of money and animal food were taken to Small Miracles Animal Shelter.

In November, we began to offer youth worship on Sunday evenings—Faith First at 5pm. This monthly service aims to engage youth in worship and train them in worship arts so they can be EMs, liturgists, etc in the wider church. We have averaged 50 people at each service. The hands-on, intergenerational, interactive service has brought families back to worship that we haven't seen in a while. It has been lovely to watch families pray together in the prayer stations, feel empowered to light candles, and discuss scripture with each other.





Discovery Weekend was a smashing success, January 20th-21st. We had 45 youth and at least that many adult volunteers. We invited back band WithLove, who led the youth in powerful worship and uplifting song. We celebrated the life that is given to us through small groups, games, mission, and worship. Small Group lessons were updated to fit our needs and provide a deeper spiritual aspect. SJEC Vestry, Youth Commission, and Outreach Commission provided meals for everyone. Our 10th-

12th grade mentors did a phenomenal job of leading discussions, giving "talks", leading by example, and reaching out to younger youth to make them feel included.

J2A led a well attended pancake supper for Shrove Tuesday. It was a joy to be in fellowship with so many parishioners! YAC helped CFF with crafts for children.

We brought the Matsiko World Orphan Choir to Ellicott City in March. They have been traveling the country for 6 months and they shared their joy of the Lord and passion for education with us. We had six families who hosted the children and their leaders as well as adults who provided meals for the choir and our youth. Host families had a BLAST getting to know these wonderful youth and the concert they provided for us was magnificent!



The 2022-2023 program year was a great year for St. John's youth program. We had new experiences where we met others who were very different from us and explored creation, worshiped God in hands-on ways, served the SJEC community as well as the world around us, and deepened our faith through weekly formation. I look forward to all that is to come!

Adult Faith Formation Report

The mission of St. John's is as follows: "We strive to bring all people to a closer relationship with God and each other in Jesus Christ." Everything we do as part of Adult Faith Formation at St. John's is informed by and tries to build upon this mission statement.

I am very grateful that with the support and encouragement of Rev. Ann, and the skill and tenacity of my co-chair, Katie Baughman, we have re-constituted the Adult Faith Formation Committee as of July 2022. The membership of this committee (in alphabetical order) is as follows: Katie Baughman (Co-Chair), Matt Chander, Sally Goss, Tom Goss, Rev. Stephen Hagerty (Co-Chair), Carol Kinloch, and Lowell Wilson. The committee meets over Zoom once a month, and recently met in person in April 2023 for a two-hour planning session for the Fall 2023 Program Year.

The majority of Adult Faith Formation is oriented around these activities: preaching, the sacramental rite of reconciliation, three weekly bible studies, Sunday Morning Adult Faith Forums, and 8-week small groups. (I have provided some data on participation below.)

WEEKLY EVENING BIBLE STUDY (2019-22)

The weekly Bible Study I facilitate now meets on Thursday evenings via Zoom from 6:15 p.m. to 7:30 p.m. We continue to focus either on a scriptural theme (e.g., forgiveness) or work our way through a particular book of the bible. Our attendance averages between 10 to 15 participants, sometimes higher, depending on the theme/bible book we are looking at. In addition, we support the fantastic work of Bruno Reich's Sunday Morning Lectionary Bible Study, which has resumed meeting in person (as it was previously meeting over Zoom) on Sundays at 8:00 a.m. in the Parish Life Center Library. The Women's Bible Study continues to offer an outstanding offering on Thursday morning, with a focus this year on the history and theology of the stained-glass windows in the Historic Church, a focus on the psalms, a multiweek study of the book by Lewis Smedes, "Forgive and Forget: Healing the Wounds We Don't Deserve," and a focus on Presiding Bishop Michael Curry's, *The Way of Love*.

ADDITIONAL ACTIVITIES

I also continue to be involved with the Youth Ministry program, and with helping to supervise Georgi Funderburk, Interim Youth Minister, and that has been very meaningful, particularly the confirmation retreats and preparation. And as of this fall, I was invited to work with the Women's Bible Study group to teach and attend their nine-month program, which is very well attended and organized.

As of this upcoming October 1, 2023, I will have been at St. John's for five years. I remain very grateful for this parish and its people, as well as to work with my fellow clergy and staff, of whom I have the utmost respect (as well as the real pleasure with which to work).

My constant prayer is that we continue to go deeper and embrace our mission:

"We strive to bring all people to a closer relationship with God and each other in Jesus Christ."

Mission Statement:

The mission of the St. John's Social Justice and Transformation Commission is to educate and equip St. John's worshippers to love and serve the Lord in their neighborhoods and wider communities in order to have a more just world.

The Social Justice team came together in 2018. Each year we have focused on a new aspect of justice, such as criminal justice reform, food and housing insecurity, racial justice, and in the current year, refugees and immigration. Starting in May, we will begin to focus on environmental justice. It is our hope that our initiatives will lead St. John's, as a community, to take on advocacy and service in the wider community of Howard County and Maryland. We are excited to have in-person events again.

2022-2023 Program Year: Social Justice & Transformation Commission Initiatives and Programs

• Through the generosity of parishioners and a St. John's Matthew 25 grant, during the last three years St. John's has provided 312 Reentry Backpacks to men and women being released from incarceration in Howard County. We currently have adoptions for 20 of the 97 backpacks we have to fill. The backpacks help to bridge some of the gaps for basic needs until these men and women are able to find some security in their housing, food, and clothing. St. John's groups, families, and individuals adopted backpacks. Please contact SocialJustice@stjohnsec.org to adopt and fill some backpacks or make a donation for team members to make purchases.



- Team members joined Christ Episcopal Church in a multi-faith-community effort to support an Afghan refugee family resettling in Howard County, under the purview of Lutheran Social Services. Many in the congregation have contributed time and money to help fund and facilitate this effort.
- We have posted book and film resources on the St. John's website at <u>www.stjohnsec.org/social-justice</u>.
- We formed a history work group and asked some parishioners to research and update the history of St. John's to reflect how St. John's fit into the broader community and America's history throughout the parish's 200 year history.
- We hosted "Sundays at Six: Becoming Beloved Community," four sessions that each included a potluck dinner, film, and discussion from The Episcopal Church's Sacred Ground series. The films we viewed were from the PBS series, The African Americans: Many Rivers to Cross with Henry Louis Gates, Jr., Episode 1: The Black Atlantic: -1500-1800; the documentary "Slavery by Another Name"; from America Inside Out with Katie Couric, Episode: White Anxiety; a Sermon by The Right Rev. Eugene Taylor Sutton, Bishop of Maryland Diocese, at General Convention, July 10, 2022; and the documentary The Trail of Souls: A Journey Toward Truth and Transformation.

- With the Outreach Commission, we hosted the "United We Pray" interfaith vigil for refugees at St. John's. This was sponsored by St. John's, Columbia Jewish Congregation, Dar Al-Taiwan, Hindu American Seva Communities, Patapsco Friends Meeting, and Christ Church.
- The Lenten Series on Refugees and Immigration featured an evening with parishioner Jim Purcell, who supervised programs and operations that reached millions of refugees, migrants, and displaced persons, including the U.S. Bureau for Refugee Programs. In the second session, we viewed and discussed the film Seeking Asylum. In the last session, we hosted a panel discussion with Delegate Mark S. Chang, State House of Delegates, D32; Michael David, Ph.D., J.D., Co-chair, Indivisible HoCo Immigrant Action Team; Barbara Day, Interim CEO, Luminus Network for New Americans; Jonelle Ocloo, J.D., founder, The Law Offices of Jonelle Ocloo, LLC; and the Rev. Denise Schiavone, Christ Church Columbia.
- We hope that you will join us in the fall for "Sundays @ Four: Becoming Beloved Community". Over a potluck meal, program, and discussion, we will begin to look at environmental justice.

Outreach Commission Report Submitted by Dave Gradwell

"I tell you the truth, whatever you did for one of the least of these brothers of mine, you did for me." Matthew 25:40

The COVID-19 pandemic continued to inhibit some of St. John's Outreach events, but the Commission continued to restart many events successfully. We are hopeful that the pandemic has ended, and we plan to return to our usual efforts and new ones. We also plan to continue the new efforts we have begun. We will be finishing our discernment process and hope to improve our programs and communications.

The Commission had some new members in 2022-23 and has met primarily via Zoom. The members included: Susan Watts Bryant (Vestry Liaison), Andrew Sutula (2022 Youth Member), Jack Stachera (2023 Youth Member), Marjorie Bray, Dave Gradwell, Doug Hall, Kate Lyon, George Maestri, Ellen Rabe, Sharon Runge, Diane Standeven, Bonnie Sturm, Marsha Trant, and Elaine Trogdon. Their efforts are whole-heartedly appreciated by the partners and recipients of our outreach efforts.

A recap of Outreach Commission Activities in the past year:

Discernment

We continued the discernment process for the commission, its vision, and mission led by the Rev. Dr. Katrina Grusell. In the Spring of 2022, we concluded the first phase with a Service of Reconciliation and Recommitment which Katrina had developed for us. The service was led by Rev. Ann Ritonia and Katrina. We then continued the discernment process led by Rev. Canon Chris McCloud of the Diocese of Maryland, to create a vision, mission, and future direction for Outreach. She met with the Commission and led us in creating an anonymous survey of St. Johns leadership and then a survey of all parishioners. The survey of leadership was completed in March 2022 with 27 of 30 responding. The survey of the entire parish was conducted in January 2023 with 140 respondents submitting answers to all the survey's questions. Rev. Chris then met with Commission and discussed Survey results in its March 6 meeting. Improving communications and developing more processes are initial areas to address. The Commission will continue to review the results and have additional meetings with Rev. Chris.

St. Johns Rummage Sale Returns

After a 2-year hiatus because of the pandemic, the St. John's Rummage Sale came back to life from June 12 - June 18, 2022. It was a wonderful community event, both for our St. John's family and for the broader community as well. With over 160 volunteers from multiple services and age groups in our parish, we were able to provide clothing, toys, and household items to those in need in our local community, donate our left-over items to 8 charitable organizations at the end of the sale, and make \$21,617 to support Outreach programs in the process. It was a fun and rewarding experience for all who participated and one we look forward to again this year from June 11-17, 2023. Congratulations to Elaine Trogdon on a tremendously successful event, and thanks to Monica Fabbri for her advice and counsel transitioning the leadership to Elaine.

St. Johns was also able to continue to serve the needs of our long-time Outreach partners through parishioners' ongoing acts of generosity.

53 households at The Club at Collington Square were supported with groups and individuals. Large amounts of toys are donated each Christmas season by our PDS. This Easter each scholar at the Club will receive a Spring Jacket. Each basket also contained a \$40 grocery store gift card made possible by Christmas and Easter Baskets collections from the parish, a.k.a. "Pots and Pans". Diane Standeven has worked closely with the Club leadership to support the program in additional ways, including \$2200 in supplies. A \$6500 check from the Outreach Commission was given to the Club to continue their efforts.

Christmas and Easter baskets of food, small gifts, and \$40 grocery gift cards were donated by parishioners and delivered by them to 34 group homes of the <u>ARC of Howard County</u> for adults with developmental, emotional and/or physical disabilities. Bonnie Sturm continues to coordinate this effort.

Elaine Trogdon coordinated our Service over Self (SOS) Day at The Children's Home in Catonsville on October 1, 2022 which involved sorting donations for the residents. Our team of 10 volunteers helped organize several rooms of clothing, shoes, games, electronics, and school supplies so that items were more readily accessible for distribution to the residents. In addition, the Commission donated \$2000 to support the work of The Children's Home. Ongoing opportunities to volunteer at The Children's Home are published in our Blessings E-News and on the St. John's website.

Fifteen to twenty Outreach casseroles were prepared by parishioners each month and frozen at St. Johns. They have then been delivered by Bonnie Sturm to The Children's Home, Baltimore County Westside Men's Shelter, Grassroots Crisis Intervention Center, and the Grassroots Day Resource Center. In addition to the food donations by parishioners, the Outreach Commission donated \$5,000 towards the operational costs of Grassroots.



Beginning in February 2023, under the leadership of Kate Lyon and Sharon Runge, the Outreach Commission resumed serving early dinner meals once a month at the <u>Day Resource Center</u>. Find the sign up to serve and/or donate food for the meal (4th Wednesday of the month) at <u>www.stjohnsec.org/outreach</u>.

Together with members of St. James Episcopal Church Lafayette Square, the St. James Academy (SJA) ministry to Baltimore City youth continued through 2022-23. Through fundraising efforts and a small endowment fund, SJA funds about \$40k a year for elementary school age kids in west Baltimore City. Despite pandemic obstacles, remote after school support programming continued at Harlem Park Elementary, and a summer program was provided at the St. James Parish Center. The return of the <u>live</u> Dr. Phil's Big Band to St. John's Church occurred as hope, was well attended and successful.

Outreach (continued)

Elaine Trogdon coordinated the St. John's Coat Drive which took place from October 30th – November 20, 2022. Although our collection was smaller than usual this year, most likely due to less people attending in-person services at the time, we were able to donate approximately 100 children and adult coats to be distributed at the Bea Gaddy Foundation's Thanksgiving Dinner event. Each year our donations of coats and other winter accessories are highly sought after by those needy families in Baltimore attending this event.

Our usual efforts with <u>Rebuilding Together Howard County</u> could not be done this year due to the pandemic.

The Outreach Commission continues to host Food Collections combined with Labyrinth Walks about four times per year.

St. John's worked with Inter-faith outreach partners in the past year.

St. John's continues to partner with Christ Church Columbia (Episcopal), Columbia Jewish Congregation, and the Columbia Friends to sponsor a refugee family from Afghanistan. Lutheran Social Services and other organizations are also involved. Deacon Denise Schiavone is leading the effort for Christ Church and partners. Several parishioners have expressed interest in supporting the effort and about a dozen St Johns parishioners have been vetted by the US government for contact with the family. The family has been living in a townhouse for over a year and family members have jobs and are attending school. The Commission approved an additional \$1,000 over the \$1,000 of 2022 parishioner donations to support the Refugee Ministry partnership with Christ Church.

The funds from the auction and previous fund raising also supported the following programs:

\$1,000 to support the work of <u>UMBC Retriever Essentials</u>, providing food to UMBC students in need.

\$500 for the Howard County Food Bank to support those who are food insecure.

\$500 to support Luminus, an organization supporting new Americans.

\$250 to sponsor a team in Kenya's Running To Read event.

\$7,000 to Kenya Connect to provide deworming medications to students and teachers at partner schools in rural Kenya.





Outreach (continued)

Although we missed engaging with parishioners in some of our hands-on outreach, we are grateful for the parish's generosity which allowed us to support these outreach partners in the manner they indicated was the most helpful.

A Special Shout Out: The Outreach Committee is deeply grateful to the students, parents, faculty and staff at St. Johns Parish Day School. They partnered with us to support our initiatives with abundant generosity. They provided food to the Howard County Food Bank and collected toys for the Collington Square Christmas baskets. We are especially grateful to Dani Boarman who coordinated these initiatives.

The Outreach Commission invites all parishioners to participate in our initiatives and provide input on how we engage more of the St. Johns community in our work. We are always seeking new members, so consider joining us in the next program year!



Kenya Connect

Kenya Connect's work to strengthen education at 63 partner public school continues to thrive. In 2022, we opened the Library Learning Center (LLC) which houses a library, makerspace, sound studio, meeting spaces and staff offices. Our Library is the only community library for over 100km and houses a collection of 36,000 books. It was wonderful to have SJPDS teachers, Katie Ficca and Sean McDonald, Board Chair Cindy Dyer, and parishioner Dana Blair at the opening of the LLC with Executive Director, Sharon Runge. We also welcomed Marsha Trant in October and Phil Stackhouse, Laura and Chris Cochran, Steve and Tina Sharpe and Sharon and Mike Runge in February. Interactive lessons, makerspace activities, STEM classes, book cataloging and shelving, and program development were all part of the volunteer activities. We are especially grateful to St. John's for your support via the Outreach Committee for our deworming program which provides meds and handwashing lessons to help learners stay healthy and in-school. The annual KC5K was a tremendous success and it was wonderful to have the race hosted at St. John's on April 1. Kenya Connect is also very thankful to SJPDS for raising a record \$18,000 during their annual Walk for Wamunyu which is providing support to our borehole and water project. Grief Ministries

Grief Booklets

At key intervals during the first year of mourning, grief booklets that assist in the journey through grief are given to grieving parishioners on behalf of the Pastoral Care Commission.

Prayer Chain

The use of technology enables parishioners to pray for people through an established email network. Upon receipt of a prayer request, a leader of the Prayer Chain composes and sends a written prayer to the members of the Prayer Chain, a group of people committed to daily intercessory prayer for those in need. Walking the Mourner's Path

Through our vision for a sustainable ministry, St. John's Walking the Mourner's Path (WtMP) ministry is committed to meeting the fluctuating needs of our faith community. We continue to offer the ministry virtually and in-person, maintain a list of resources comprising various forms of media, and we connect with other St. John's ministries through worship, the Garden of Standing Stones, and the labyrinth.

Loss shapes us. When a loved one dies, we are forever changed and the grief we experience is a natural response to loss. As God heals us in our grief, we learn to carry our loved ones who have died with us as we rebuild our lives without them. Walking the Mourner's Path gives space for that inner transformation to happen through eight weekly small group workshops. This year two workshop series were held,

guided by our dedicated team of four trained facilitators who encouraged participants to open themselves to the Holy Spirit.

After completion of the workshops, participants are invited to attend Gatherings to share a potluck meal (when in-person), connect and learn from one another as they continue on their healing path. WtMP facilitators plan helpful interactive programs for the Gatherings using multimedia content from our list of resources that promote healing through healthy practices. Following the first 2022 Gathering, which was held online, we emerged from the isolation of COVID and hosted a picnic-style Gathering on the lawn under the tent. The last of the three Gatherings was the special All Saints' Day Eucharist, where alongside the community of St. John's, we came together to



mourn the dead, affirm hope in the resurrection, and to live into the fullness of who God calls us to be. Whether online or in-person, we gather as God's beloved.

Volunteers continue to be pillars of this ministry and we extend our humble gratitude to the extensive list of parishioners who have graciously agreed to serve in our ministry as Prayer Partners. Likewise with gratitude for their faithful service, the ministry's facilitation team says farewell to facilitators, Teri Salmons and Nancy Voskuhl, who are now serving in other ministries, and The Rev. Katrina Grusell, whose dedication, wisdom, and guidance profoundly enhanced the quality of care we provide.

The Compassionate Friends: Community Organization

In 2022, St John's continued its relationship and support of The Compassionate Friends (TCF), an organization dedicated to providing a place for people who are dealing with the death of a child, grandchild and/or sibling due to any cause. The Patapsco Valley Chapter meets monthly on the first Thursday of each month 7:00-9:00 p.m. to deal with the grief of loss while providing support to those in need. The meetings are open to all who wish to participate.



The chapter has membership of over 100 people and more than 290 people attended during 2022. In addition to the monthly meetings, we always participate in the World-Wide Candle Lighting. Held the second Sunday of December each year, the WWCL was held in the Historic Church to remember our loved ones. TCF also has more than thirty-five private FB pages for people to seek support between meetings; over 100,000 people participate in these groups. Additionally, there are moderated chat rooms for online meetings.

Many other organizations have received grief support through our chapter. Wings for Val, Sinai Hospital, James Place, Ariel's Bear, Warrior Canine Connection and others are benefiting from bereaved families who are transforming grief into a positive force for others. Other organizations in the community also send people to Compassionate Friends for support. These include Slack Funeral Home and Howard County Police Department. Barbara Allen assists with the International Overdose Awareness Day.

TCF expresses its extreme appreciation to St John's for its continuing support of the program in providing support to the bereaved of Howard County and beyond.

Bereavement Committee: Patricia Stackhouse

With the easing of Covid restrictions, we have been able to begin doing receptions again. Our volunteers have supported several families, either with luncheons or with mid-afternoon tea, coffee, and dessert. This remains a real opportunity for people to support those going through difficult times of loss. Help can be either food dishes or work setting up, serving and cleaning up for events. We have the gift of serving those in need but also have the gift of receiving a sense of community and productivity as we work together. Meals Ministry: Sue Carlson

The Meals Ministry team provided meals for four parish families and two of St. John's staff this year who experienced a crisis, illness or loss. Length of support varied from several weeks to several months. We were able to transition to a hybrid model for meals, delivering either a fresh or frozen meal (or both!).



The Meals Ministry team works hard to:

- be cognizant of the recipient's dietary requirements
- determine whether a fresh or frozen meal, or both, would best serve the recipient
- be aware of current Covid and other virus/illness spikes in the community
- let recipients know that <u>many good thoughts and prayers</u> accompanied each and every meal.

Meals Ministry responded to a request to have frozen, 'grab & go' meals immediately available for clergy to use as needed. This system, which allows the clergy to respond quickly to an urgent need, was underutilized and may be restructured.

The Meals Ministry team owes a <u>tremendous debt of gratitude</u> to Facilities Manager Russ Warner, Junior Warden Mike Salmons, and all facilities personnel for their planning and hard work making the Rose Hill kitchen and freezer available for use by Pastoral Care. It has been easy, convenient, and a joy to deliver and retrieve meals at any time without impacting function of the Day School.

Stephen Ministry: Judy Anderson and Tina Millard

There are times when every one of us experiences difficulty: acute or chronic health diagnosis, job loss, death of a loved one, stress of parenthood or caregiving, and many other challenges that bring about suffering, or caring for those who are. God never intended for us to go through these experiences alone. Our specially trained Stephen Ministers provided high-quality, confidential Christian care to people experiencing challenges in life, meeting one-to-one with individuals to listen, support, encourage, pray, and reflect Christ's presence.



In the spring, the St. John's Stephen Leaders held a Supervision Group Facilitator training course where six individuals within our Stephen Ministry consortium of area churches were trained to facilitate Stephen Ministry Supervision groups. Ongoing, regular Supervision is a key to helping Stephen Ministers provide the highest quality of care possible.

Seventeen Stephen Ministers and The Rev. Katrina Grusell served in Stephen Ministry in 2022. Of those 18, four served as leaders while another four Stephen Ministers also served as Supervision Group Facilitators. Sadly, and yet with profound gratitude, we said farewell to Stephen Minister Brad Muir and Stephen Leaders Cynthia Cecil and Rev. Katrina, whose inspired wisdom and dedicated leadership enriched us as spiritual caregivers.

Click of Comfort, Prayer Shawl Ministry: Judy Anderson

The Prayer Shawl Ministry was began in 2006. Since then, *nearly* 700 hand-crafted prayer shawls have been distributed to parishioners and friends. Hundreds of mini-prayer shawls have also been distributed during the One Service day Fair and from the Narthex as a reminder of Christ's healing grace. The shawls are now kept in Rose Hill, so that they may be included with food taken to those in need.

Lay Eucharistic Ministers: Clergy

In an abundance of caution, Clergy have been providing this service since the COVID pandemic. We expect recruitment of Lay Eucharistic Ministers and training to be scheduled for late 2023.

Flower Ministry: Kathy Young

Mental Health Ministry: Moves to Become the Center for Spiritual & Mental Wellbeing: Karen Ferguson

Using grant money which Rev. Katrina Grusell obtained, the Center for Spiritual & Mental Wellbeing in Rose Hill has been transformed into beautiful meeting spaces for one-on-one meetings as well as small group meetings and meetings of the Pastoral Care Commission and other Pastoral Care ministries. This ministry will continue to evolve with the leadership of Karen Ferguson. We are very grateful for the ministry of Debbie Lieberman who will continue on the Advisory Board of the evolving organization.

Annual Meeting — 1 May 2022 — Minutes

The 2022 Annual Meeting of St. John's Episcopal Church, Queen Caroline Parish, Ellicott City, Maryland was called to order by the Reverend Ann Ritonia, Rector, at 12:00 pm on Sunday, May 1, 2022.

A prayer was given.

A motion to adopt the agenda, as printed in the Annual Report and shown on the overhead projector, was made by Ken Wireman and seconded by Jennifer Wamble and approved unanimously.

Mike Runge was appointed as Secretary, and it was determined that those present in All Saints' Hall (approximately 70 members) constituted a quorum. Phil Stackhouse was appointed as Parliamentarian.

The Necrology was read.

The 2021-22 Annual Report was distributed electronically prior to the Annual Meeting and printed versions were made available at the meeting.

Last year's Annual Meeting minutes were moved for approval by Mike Salmons and seconded by Ron Buchman. No corrections were made. The motion was approved unanimously by voice vote.

Elections

Dan Wise, chair of the Nominating Committee, reviewed the eligibility requirements for voting, as delineated in the by-laws, and the rules for balloting. To vote, you must be at least 16 years old, a baptized member for at least six months, faithful in corporate worship (unless for good cause), and faithful in working, praying, and giving for the spread of the Kingdom of God. Giving is defined as making an annual pledge to St. John's.

This year, the Nominating Committee consisted of Dan Wise (chair), Katie Baughman, Judy Anderson, Scot Millen, Matt Maloney, and the Rev. Ann Ritonia. The committee met several times in February and March, conducted informational meetings, and spoke with many qualified and dedicated members to put together a slate of candidates. The committee recognized that St. John's is blessed with many gifted lay members dedicated to the parish. Chair Wise thanked the nominating committee for their service.

The Nominating Committee recommended the following list of candidates:

Four candidates for three-year terms on Vestry (as the class of 2025): Rebecca Daughterty, Lucy Eldridge, Tom Goss, and Doug Hall.

One candidate to serve a two-year term on Vestry (in the class of 2024, to complete Kara Zaron's term): Geoff Walker.

Two candidates to serve as Lay Delegates to the Diocesan Convention: Brian Stone and Ron Buchman.

A motion was made by Mike Salmons and seconded by Susan Watts to accept the nominating committee report, close nominations, and proceed with the election for the Vestry Classes of 2024 and 2025 and for the Diocesan Convention. The motion carried unanimously by voice vote.

Inasmuch as the number of candidates was not more than the number of vacancies on the Vestry and for lay delegates to the Diocesan Convention, the election was uncontested.

Dave Bunnell made a motion, which Ron Buchman seconded, to elect by acclamation the slate of candidates who were presented by the nominating committee and accepted by the voting members present. There was no discussion. The motion to conduct the election by acclamation carried unanimously. The election of the nominated Vestry candidates and lay delegates carried unanimously by acclamation.

Reports

The Reverend Ann Ritonia presented the Rector's Report. She provided a brief overview of the accomplishments in the last year that are detailed within the Annual Report. She expressed thanks, especially to youth and childhood education leaders, for overcoming the challenges of faith formation over Zoom and providing safe space for community building. In the coming year, we'll undertake a strategic planning process, which the congregation will be invited to participate in. There have been challenges this year, especially with finances, as we sought to balance the demands of ministry, rising costs, and good stewardship. The average pledge has increased, but the number of pledges has declined. Through several generous gifts, we have been offered a \$11,000 challenge match; it's not too late to pledge or increase your pledge. Rev. Ann concluded by expressing gratitude to the vestry, to her clergy colleagues, and to the staff that support St. John's every day. Nothing is possible without God, as we live into our baptismal covenant.

outgoing Senior Ken Wireman, Warden, presented the Senior Warden's Report. When he and Rev. Ann first talked about his serving as Senior Warden, neither of them could anticipate the pandemic; it has been a challenging time. He has embraced the role that is sometimes called the "Rector's Warden", and has enjoyed his time working with Rev. Ann. He closed with three reflections: (1) we need to make sure we're a welcoming church, and part of that includes taking upon ourselves to be welcomed; (2) as well each examine our gifts and talents, we should ask, how do we contribute to the life of the parish; and (3) over the past three years, he has come to understand that God gives us what we need, and what we needed was Rev. Ann.

Mike Salmons presented the Junior Warden's Report. The first year of being junior warden was a firehose of experience! We fixed a *lot* of things this year, and rediscovered a few things that we had broken before. A few highlights include:

refurbished pews in the historic church; the renovation of the ground floor of Rose Hill; last fall, a bolt of lightning fried the air conditioning in the Historic Church, but we have just signed a contractor to repair that; mitigation of an erosion issue that affected water flow into neighboring cemetery; and the overall increase in costs this year. The Junior Warden introduced the new Facilities Director, Russ Warner, who he described as methodical, conscientious in vetting contractors, and expert with HVAC, electricity, and plumbing. Russ Warner, who was a pastor himself earlier in his career, addressed the meeting, giving thanks for the guidance and support from Rev. Ann and Mike Salmons. The Junior Warden then introduced Richard Lawson, who is on the maintenance team, and has been at St. John's for 25 years, and thanked him on behalf of the parish for 25 years of service. Mr. Lawson received a standing ovation from the Parish. The Junior Warden then addressed what's coming up in the next year. He needs some volunteers to fix a lot of things and would like to re-form some like the Men's Club. We're embarking on a reserve study: a mechanical firm will come in to study every single element of our campus, and they'll tell us how much time it has yet and what the price tag will be. Finally, he offered thanks to so many people for Campus Clean Ups, especially Day School staff, parents, and students.

Ann Corbett presented the Treasurer's Report. Fiscal (and calendar) year 2021 was tough financially for St. John's, as it was for many churches, because of the pandemic. For the second year, we received \$136,699 from the Paycheck Protection Program; we received verbal forgiveness from the bank for this loan and expect to hear from the Small Business Administration soon with the official notice. The Diocese of Maryland took a 5% reduction in pledges from parishes, which helped our bottom line. We received \$978,777 in pledge income (\$21,000 less than budgeted), but this was offset by higher-than-expected investment returns. Expenses were about \$6,000 less than budget. In

all, we finished 2021 with a modest surplus. For 2022, the Vestry has approved a budget that includes \$1.26 million in receipts, with \$954,744 of that coming from pledges and \$86,000 coming from the Parkview Fund. We have requested and received financial assistance in the amount of \$32,000 from the Diocese (in the form of a reduced Diocesan allocation), made possible through Diocesan pledges from other parishes. The 2022 budget includes a 3.0% cost-of-living increase for parish staff, the first since 2018. Budget reductions have been taken in some other areas. As of April 25, 2022, we have pledges totaling \$924,572; this is still about \$30,000 below our budget target. The Treasurer thanked each pledging household and mentioned again the challenge match—we will be grateful for any other households that respond to increase their pledge. Some years ago, the parish took out a 30year mortgage to fund the construction of the Center for Ministry and Education; a balance of \$3.6 million remains. The last and final reset of the interest rate was in December 2021, at 1.67%. The parish and the Day School both use the CME, and each pay a portion of the operating expenses. In 2019 and 2020, the parish had to take over some of the expenses, but the Day School has repaid \$100,000 and will be repaying another \$50,000 by the end of the school year (June 2022). The Day School is thriving and we are blessed to have it. In summary, 2022 is proving to be a challenge financially, especially as we must tap into some our investments, but we will regather, renew, and re-strengthen relationships. We are grateful to all of you for your gifts.

Ann Corbett, the Treasurer, entertained questions from the parish members present.

Judy Robbins asked about the rental status of Clark House. Response: Peabody Conservatory is leasing Clark House. It's bringing in a significant amount of income. We're hoping that in 2024, they'll be able to use our larger spaces and their children's choir will be located here.

Gordon Knox asked when the \$11,000 match challenge ends. Response: the challenge will remain in place for the entire year.

Chris Cochrane asked whether the returned funds from the Day School appear in the 2021 budget. Response: no, those funds are not part of operating budget, instead, they appear on the balance sheet.

Chris Cochrane asked about all the investment funds we have, for example, the Parkview Fund. Response: behind the Ellicott City PO, there's an apartment complex called Parkview. At the time of its construction, the builder needed a non-profit to help with the loan application. For \$10 and a handshake, St. John's supported the project. Once the complex was built, we received an unexpected windfall of approximately \$300,000 from that investment. We're using some of that to balance the budget this year.

Chris Cochrane asked what happened to the funds from the sale of the house on Chatham Lane. Response: those proceeds were used to pay the school's share of operating expenses in 2019 and 2020. Most of that income is in the "Vestry Account", a conglomerate of various earmarked funds.

Chris Cochrane noted that in the Treasurer's written report, there is mention of a structural deficit, and asked for clarification. Response: to balance the budget we have, we would like to see \$1 million in pledges, but we're quite a bit below that. For 2022, we're drawing from investments and have received temporary support from the Diocese, but we would like not to have to do those things. An increase in pledges of about \$200,000 would fix the structural deficit and allow us to do even more.

Anna Loomis asked about the analysis in the Stewardship Report (pp. 55-57 in the Annual Report) regarding the number of pledges. Do we have a high-level grouping of the changes in number of pledges, do we have stories for why people haven't pledged? Response: the analysis goes through 2021, but we haven't included 2022 yet. During the pandemic, people got used to not coming to church. Will they come back? We need to reach out to people and encourage them to come back. We lost a number of people through death, moving away, losing jobs. Some weren't coming to church and didn't see a reason to pledge. And some haven't been happy with the church and didn't pledge as a result. So, it's a mix of things.

Chris Cochrane asked about the timing of pledges, 2018-2021. Is it fair to say most pledges for 2019 were made by the end of 2018? Decreases in 2021 might be pandemic related, but decreases before that were driven by something else? Response: most 2020 pledges were made before March 13, 2020.

The Treasurer acknowledged Kathy Hahn, her hard Finance Director, for Documentation for the PPP loans was very difficult. We were being audited. renegotiated a mortgage. There was a lot going on. We're so grateful for Kathy's work holding the finances together.

Chenwei Gillis, Chair of the Board of Trustees, presented the St. John's Parish Day School Report, including highlights for the 2021-2022 school year and the outlook for the 2022-2023 school year. She referred the congregation to the written report for details. The 2021-2022 school yhear has gone very well. The current enrollment is 296, which is a full house under the current COVID-19 restrictions. The annual fund raised \$80,250, exceeding the goal of \$75,000, and this was done without a major fundraising event and without a full-time

director of development. The annual Walk for Wamunyu raised \$11,800 for the school's Kenya Connect sister school. The school is running a surplus budget for this year, showing a landmark achievement of sustainability. By the end of May 2022, the school will have repaid \$350,000 of its debt to the parish; the Chair noted that the school is grateful for the support the parish provided during previous tough times. The school is working to increase salaries for faculty and staff; they are in the second year of a three-year plan to bring the salaries up to the regional average. The school was recognized as a 2022 Best School in America by Niche, with an A+ grade for the second year in a row. During the pandemic, the school's management protocols were successful, allowing them to keep open for in-person instruction the entire year with only very limited, isolated incidents. The day school is working to improve its academic credentials and enhance the existing curriculum. AIMS reaccreditation is coming up this year. The school has undertaken an aggressive marketing campaign, presenting itself as a diverse and inclusive place for all students, and offering a 10% discount for active military families. Staff professional development has included several diversity, equity, and inclusion (DEI) trainings.

Chair Gillis noted that the school expects a very successful 2022-2023 school year. There has been high interest at open house events and enrollment is already 293, that is, 98% full. At this time last year, enrollment was 285, so they are expecting a full house again. Over 30 families from the 4-year preschool program will continue into kindergarten, which is an extremely strong rate of retention. The school budget will continue to see a surplus and they will continue to repay past debts to the parish. All of the faculty have returned their contracts for next year, which is significant given the challenges other schools are having recruiting staff in the current job market. Chair Gillis expressed her deepest gratitude to Rev. Ritonia

and the Vestry, for their ardent support of the school. Chair Gillis also expressed thanks to Lori Dembo, the Head of the School, and her team for their very hard work and dedication. Rev. Ritonia thanked Chenwei for her leadership as Chair of the Board, and attributed the extraordinary success of the school to the Board and to Lori Dembo.

Election Results

All of the newly elected vestry members were present. An oath was administered to them.

The newly elected Lay Delegates to Convention, Ron Buchman and Brian Stone, were acknowledged.

Members retiring from service on vestry were recognized: Katie Baughman (not present), Mike Runge (present), Ken Wireman (present), Phil Stackhouse (present), Nancy McAllister (present), Kara Zaron (not present).

Recognition and Awards

Rev. Ritonia presented the annual awards.

Thomas Cranmer Award. Named after first Archbishop of Canterbury, this award was introduced in 2018 to honor a person who models a life of prayer. Past recipients were Teri Salmons, June Robinson, Sharon Weston-Dawkes, and Judy Anderson. This year, the award goes to Lucia Martin.

St. John's Cross Award. This is an annual award given to a member of Parish who in the last year has helped us fulfill our mission to bring everyone to a closer relationship with God and each other in Jesus Christ. This year, the award goes to Matt Maloney. Matt has been organizing all the ushers for the last 2 years, for funerals, Sunday services, and other events. It has not been easy during the pandemic. Matt was also on the COVID team. His grace and patience have been remarkable.

St. John's Award. This award is presented each year to a parishioner who gives of themselves, exemplifies the Spirit of St. John's, and lives out our mission in the community. Past recipients of the award were invited to assemble. The award this year goes to a member who has kept us safe with

diligent reporting on everything related to COVID, chaired meetings, and helped with stewardship. This year's award goes to Mike Runge.

Steve and Teri Davey presented a wooden lectern, built by Steve, in memory of their son, Nicholas Davey. Rev. Ritonia offered a prayer of dedication.

Questions and Answers

Rev. Ritonia invited questions from the parish on any matters included in the Annual Report.

Terry Kreft noted that if everyone increased their pledge by \$2 more per day, we could close the gap in the budget.

Anna Loomis noticed that there was mention of a potential service in the Historic Church (HC) in the fall. She asked for details and wondered whether it would affect the rest of the Sunday morning schedule. Response: Rev. Ann noted that we will add an 8:45 am service in the HC in the summer. In the fall, services will include: 5 pm Saturday; 8:45 am Sunday in the HC; 9 am Sunday in All Saints' Hall. She has heard the desire for a common coffee hour, and this schedule should allow that. Faith formation will begin at 10:30 am in the fall.

Announcements

The meeting continued with several announcements.

Sharon Runge, representing the Outreach Commission, announced that the Rummage Sale is returning June 17-18, 2022. The Rummage Sale fuels all the Outreach work, whether you're donating or helping. Please support it. Bring items! What makes Rummage Sale work is all the people that volunteer to help sort and organize. There's a sense of community in those volunteers. We love the money for outreach, of course, but it's really the fellowship we love. We hope to see everyone there!

Rev. Ritonia accounted that on June 5, Pentecost, we will have One Worship, outside, with community-building events to accompany it. The summer service schedule begins the following weekend.

Rev. Stephen presented flowers to Rev. Ann, as a small token of appreciation from the staff. The staff wanted to lift up the leadership and mentoring of Rev. Ann. One of the things Rev. Ann does so intentionally is focus on each person's individual gifts, with Jesus front and center.

Closing

Rev. Ritonia offered a closing prayer.

A motion was made to adjourn the Annual Meeting by Ron Buchman and seconded by Scot Millen. The motion passed on a voice vote and the meeting was adjourned at 1:28 PM EDT.

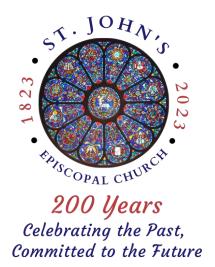

Introduction

The Stewardship Commission strives to encourage a spirit of generosity and financial commitment in all members of the parish, to support the important work being undertaken throughout the year at St. John's.

Celebrating the Past, Committed to the Future

This year, 2023, is a year of celebration for St. John's, as we commemorate 200 years of commitment to following The Episcopal Way of Love! We honor the generations of faithful folk who have placed the mission of St. John's front and center. And we honor our collective commitment to make sure, with God's help, that the next 200 years will allow St. John's to continue to be a blessing.



The spirituality we live is grounded in scripture, interpreted with reason, and enriched by tradition. This same faith has not only survived but even thrived through the challenges of three years of pandemic. Through all of this, our Parish has remained resolute to our commitment to God in Christ through our giving of time, talent, and treasure.

This year's stewardship theme, "Celebrating the Past, Committed to the Future", reflects the bicentennial celebration and asks us to imagine the next 200 years. In the requests for pledges, parishioners were asked to show our support for St. John's future with a sacrificial gift of 2% of our income, for our 200th year. Throughout October, Commission members and other parish leaders shared their reflections on stewardship through "Ministry Minutes" distributed electronically through Constant Contact (thanks to Scot Millen, Ann Corbett, Eunju Chen, Peggy Burrows, Stephen Haggerty, and Doug Hall!).

Trends in Giving

Against a backdrop of a slow, long-term decline in giving, the pandemic has created challenges for churches of all denominations. Without being able to meet in person, many churches saw a sharp drop in giving in the first year of the pandemic, even as charities in general saw significant increases. In the second year of the pandemic, emotional fatigue set in, and charitable giving declined across the board.

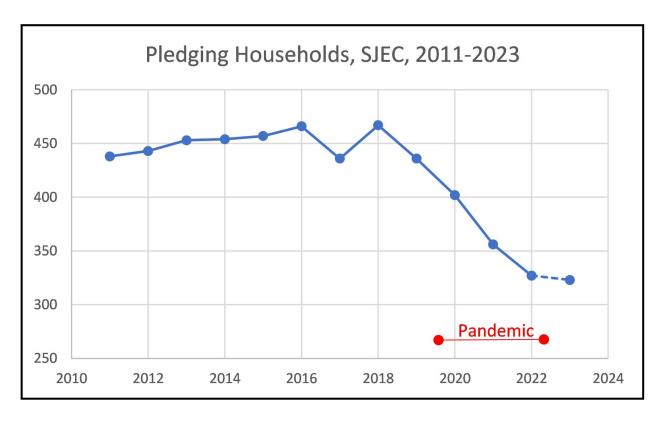


Figure 1. Number of pledging households at St. John's, 2011-2023. The 2023 pledge numbers are as of April 28, 2023, and thus doesn't represent the final number for 2023.

The number of households pledging to St. John's declined sharply through the pandemic (Figure 1), with more people suspending or stopping pledges than new households joining. This trend appears to have stopped in 2023, with the number of pledging households remaining steady.

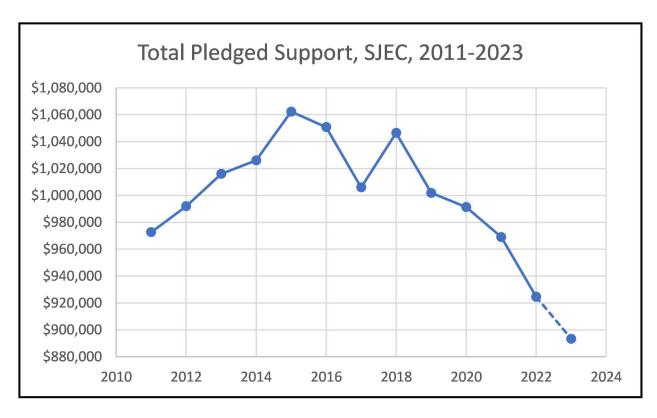


Figure 2. Total value of pledges to St. John's, 2011-2023. The 2023 pledge total is as of April 28, 2023, and thus doesn't represent the final number for 2023.

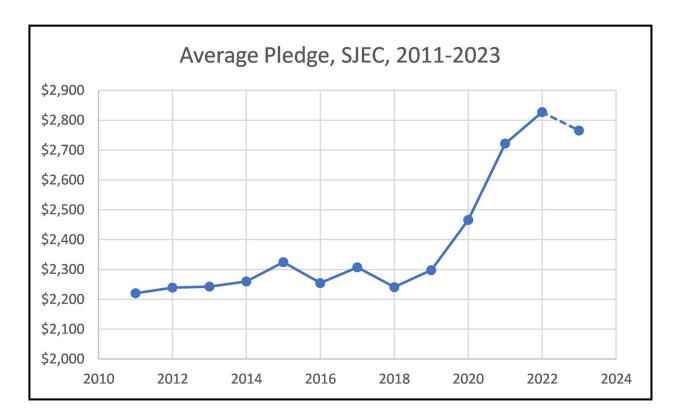


Figure 3. Average household pledge at St. John's, 2011-2023.

In terms of the total value of pledges, St. John's has seen a decline since 2015, which accelerated during the pandemic (Figure 2). The decline in pledged support is primarily driven by the decline in the number of pledges, as the average household pledge has increased sharply since 2019 (Figure 3).

Giving and Sharing: From our Treasurer



St. John's Treasurer's Report for the 2023 Annual Meeting Submitted by: Ann Corbett

Summary:

2022 was challenging in many ways. Pledging, attendance, and volunteerism for 2022 continued to be well below pre-pandemic levels. There were Covid-19 surges at difficult times—the 2021-22 Advent season and 2022 Easter season; both surges had a negative effect on offerings and attendance. In addition to \$32,000 in financial

assistance from the Diocese, the Vestry approved the use of assets from the Parkview Investment Fund in order to balance the budget. Further, St. John's experienced a host of significant facility maintenance expenses that exceeded what we expected to spend in any one year.

On the other hand, 2022 was a year of hope and optimism. As the rate of Covid-19 transmission decreased later in the year, our in-person attendance began to increase or remain steady. And we started to introduce some popular fellowships such as the weekly coffee hour, the annual One Service, and the annual parish retreat at Shrine Mont.

Overview of Financial Operations:

The operations of St. John's include: the Church, the Parish Day School; and several donor and designated funds which are tracked and reported separately from our operating budgets. The Church's fiscal year runs on a calendar year basis, January through December, while the School's fiscal year begins on July 1 and runs through June 30 of the following calendar year. This fiscal year is typical of independent schools.

St. John's Episcopal Church operates as a not-for-profit entity and has a goal of reaching a break-even budget—one in which receipts from pledges, plate offerings, investment income, and facilities usage match disbursements on items including staff compensation, faith formation programs, utilities, technology, and campus upkeep. For several years, the Church has had a structural deficit, with receipts falling short of expenditures. The Light the Way (LtW) Campaign was initiated in 2015 to cover this gap; and LtW funds have been used to cover shortfalls relating to debt service, capital improvements, and spiritual efforts as necessary.

2022 Results:

Overall receipts of \$1,195,210, including \$86,204 from the Parkview Investment Fund, were \$64,837 under the budgeted level of \$1,260,048. Pledge receipts were \$26,517 below actual pledges and \$56,689 below the budgeted pledges of \$954,744. The Easter offering came in \$5,958 below the budgeted level of \$10,000 as Easter occurred during a Covid surge. By contrast, income from use of facilities (space rentals), while slightly under budget (-\$3,339) was significantly higher in 2022 than in 2021 (\$67,456 vs. \$24,545), primarily the result of the rental agreement with the Peabody Conservatory for the use of Clark House. There were no PPP funds in 2022, compared to \$136,699 in PPP funds in 2021.

Overall disbursements were \$1,189,609, or \$60,995 lower than budgeted. Clergy compensation was \$22,400 less than budgeted, primarily the result of the departure mid-year of a part-time clergy person. Expenditures for General Facilities and Ground including Labor were \$178,486, or \$20,948 less than the budgeted level of \$199,434. Facilities custodial salaries were \$3,785 over budget due to changes in staff in that position. Service contracts were \$9,958 under budget because there was no need for snow removal.

Giving and Sharing: From our Treasurer

Repairs and Replacements were over budget by \$36,608 due mainly to repairs to the air conditioning (AC) systems in the Historic Church (HC) and the purchase of window AC units in the Shiflet Center for Ministry and Education (CME). These expenses were offset by insurance reimbursement of \$47,998 for the HC lightning strike. Utilities cost \$32,000 more than in 2021 and almost \$9,000 more than budgeted for 2022.

Including the infusion of \$86,204 from the Parkview Investment Fund, the Church ended the year with an operating surplus of \$7,651.

2023 Budget and Outlook:

The Vestry approved a 2023 budget with total receipts of \$1,105,500 as follows: Total Pledge receipts of \$900,000; Other Donations, \$87,000; Income from Investments, \$44,500; and Facilities Use, \$74,000. Actual pledges through mid-April are \$892,217.

St. John's has again requested financial assistance from the Diocese for 2023. We are aware, however, that the overall amount of financial assistance requested by churches in the Diocese, including St. John's, exceeds the amount available for the Diocese to provide. St. John's, as with many other churches, is striving to overcome the adverse impact of the Corona virus pandemic. We expect to learn the decision of the Diocese in June.

The Vestry approved Disbursements of \$1,204,503, which, absent higher-than-budgeted receipts as discussed above, result in a deficit of \$110,186. Assuming St. John's receives some amount of financial assistance from the Diocese, the remaining shortfall will necessarily be made up from the Parkview Investment Fund and/or other assets. In other words, this is a tight budget year. We remain optimistic, however, that as St. John's continues to open to the wider community and offers more fellowship opportunities (for example, coffee hour, progressive dinner, bingo night, One Worship services, annual Shrine Mont retreat), attendance and giving will increase. We are eager to work toward strengthening and growing St. John's during the coming year.

Notes on the 2023 Budget:

Pledge income is close to last year's level (\$900,000 budgeted for 2023 vs. \$898,055 actual pledge receipts in 2022). There are 34 new pledges in 2023.

Budgeted rental income from use of our facilities is increased by \$6,544 (from \$67,456 actual in 2022 to \$74,000 in 2023).

The 2023 budget does not provide for a cost-of-living adjustment (COLA). The modest 3% COLA provided in 2022 was the first COLA since 2018.

Total clergy compensation, including benefits, is reduced by \$40,028 in 2023, reflecting the departure mid-year of a part-time clergy person.

The diocesan pledge increased from \$159,924 in 2022 to \$166,936 in 2023 (+4.4%)

Giving and Sharing: From Our Treasurer

The budget will be revised at least quarterly throughout 2023. This year, the full impact of some events is not yet known (i.e., clergy transition, decision on financial assistance).

To balance the budget, St. John's may need to draw from its assets to fill the gap (\$110,186 less whatever amount of financial assistance is provided by the Diocese, upcoming clergy transition, and unbudgeted receipts).

Stewardship:

Pledges are budgeted at \$900,000 for 2023, and as of mid-April, pledges stand at \$893,317 compared to \$924,572 actual pledges at this point last year. The number of pledging units for 2023 is 323 compared to 327 in 2022; and the average pledge decreased from \$2,827 in 2022 to \$2,766 in 2023. We are excited to have 34 new pledges for 2023.

St. John's Parish Day School (SJPDS):

SJPDS is comprised of the Lower School (K through 5th grade) and the Early Childhood Program (3-year-olds through pre-K). Its school building, the CME, was completed in 2001 and accepted its inaugural class of first graders in 2002. For more information about SJPDS, please refer to the Head of School Report.

Mortgage:

The balance on the mortgage debt as of 12/31/2022 was \$3,447,840, down from \$3,685,304 on 12/31/21. The original mortgage was a tax-exempt bond issued in conjunction with the Maryland Health and Higher Education Facilities Authority (MHHEFA) in December 2001. It matures in December 2031. The interest rate is reset every ten years, and the final reset occurred in December 2021 at 1.67 percent. This bond has a debt service covenant ratio requirement which both the Church and the School met for 2022, as indicated in the most recent audit performed by Clifton, Larson & Allen (our accountants). Light the Way funds are being used to reduce the impact of the annual debt service payments on the Church's operating budget. The School pays a portion of the mortgage cost as part of its shared operating expenses (see below).

Borrowing Facility/Shared Expenses:

The Church has a \$250,000 line of credit with Sandy Spring Bank (which acquired Revere Bank) to provide periodic support for the cyclical cash flows of the Church and SJPDS. The line was last used in 2018; however, the Church did pay the School's portion of the "shared" expenses during fiscal years 2019 and 2020. The audited balance owed to the Church was \$230,937 as of 6/30/21. The School has since repaid that full amount. The Church continues to pay the full "shared" expenses for the current year; and the School pays the Church an estimated monthly amount for its portion of these shared expenses. These shared expenses are laid out in a Memorandum of Understanding (MOU) between the Church and the School that runs from July 1, 2022, through June 30, 2023. Discussions will soon be underway to update the MOU for the 2023 – 2024 academic year.

Giving and Sharing: From Our Treasurer

Middendorf Loan:

In early 2022, the AC system in the Parish Day School failed. This is the 23-year-old roof-top system that cools the Shiflet Center for Ministry & Education (CME), the Carter Wing, and the Auditorium. Over the months of January through July 2022, numerous assessments, repairs, replacement of selected components, and troubleshooting occurred, costing the Church and School approximately \$40,000. The conclusion of these efforts was the need for a total replacement of the AC system at a cost of over \$411,000.

St. John's applied for and received a Middendorf Loan from the Diocese so this work could be done. The Middendorf Loan in the amount of \$400,000 is amortized at 3% over 20 years, resulting in a monthly repayment amount of \$2,218.39. The 3% interest is waved for 2023, however. Thus, the full repayment amount in 2023 (10 months) is being applied to the principal. For now, repayment is being funded from St. John's assets.

Light the Way (LtW) funds:

The LtW campaign, launched in 2015, generated pledge receipts of \$1,278,705. These funds allow the Church to make beneficial investments in our people, programs, and campus. The balance in LtW funds as of 12/31/22 is \$259,754.

LtW funds were used in 2022 as follows:

\$45,000 in support of the operating budget for payment on the mortgage/bond \$7,380 for the balance of the patio stonework at the HC \$40,917 for work on the AC system for the CME and connected buildings \$1,190 to the College of Congregational Development for clergy education

For 2023, \$50,000 is earmarked for the following: \$45,000 for support of the operating budget for payment on the mortgage/bond and \$5,000 for education.

Organ Conversion:

Over the past several years, the organ in the HC had been experiencing more and more ciphers (an ongoing high-pitched sound that occurred even when a key was no longer being depressed). The stop-gap corrective measure involved permanently disabling the affected pipe(s) so they could produce no sound at all. Evaluations by several organ consultants suggested a complete or partial replacement of the organ, but not a rebuild. Other builders suggested transitioning to a digital or hybrid instrument.

In August 2022, members of the St. John's Organ Committee visited several churches in the Virginia and D.C. area to hear both hybrid and digital instruments. The group was unanimous in preferring the sound of the digital organ and recommended that St. John's transition the existing instrument to an "all-digital" instrument. The Vestry approved the recommendation.

The transition to an "all-digital" instrument took place in February 2023 at a cost of approximately \$93,000. By contrast, the cost of a rebuild is generally in the \$1 million range and the cost of a new build in the \$2+ million range. Approximately \$38,200 was already earmarked for organ maintenance and repair within the Music Fund. Another \$54,300 was given to fund this project, primarily by St. John's musicians and friends of St. John's music. Gifts are still being gratefully accepted to replenish the organ maintenance fund and support the Music Program at St. John's.

Giving and Sharing: From Our Treasurer

Closing:

To date, through March 31, the 2023 budget is generally on track, with a favorable surplus of \$3,321. That said, however, receipts are running 4% lower than budgeted, primarily the result of lower-than-budgeted pledge receipts (-\$5,313) and space rentals (-\$4,640). Pledge receipts reflect the absence of a prepaid 2023 pledge that was received in 2022. On the other hand, overall disbursements are \$14,122 under budget, primarily the result of having received an insurance reimbursement of \$17,719 for water damage in the CME. This will be offset by vendor payments due to be paid in April.

As indicated earlier, we began 2023 with a deficit of \$110,186. Since then, new factors have surfaced that will require revisiting the budget—most notably, the upcoming clergy transition. The departure of the current rector and the appointment of an interim rector will affect expenditures for clergy compensation; and that analysis is underway. Additionally, St. John's continues to experience higher-than-expected repairs to our physical plant.

2023 will be another tight budget year, but we are optimistic that St. John's will be able to meet the financial challenges. I you have not yet pledged, please consider pledging now. If you have already pledged, please consider an increase. We are most grateful for your support.

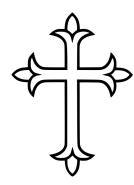


St. John's Award

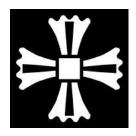
